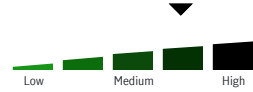

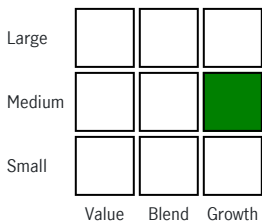

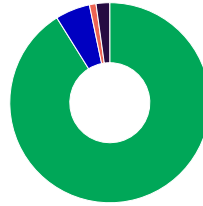

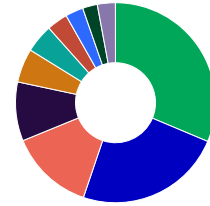
Portfolio Allocation

Geographic Allocation (%)



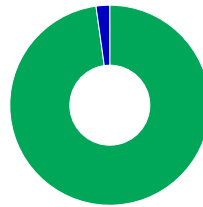
