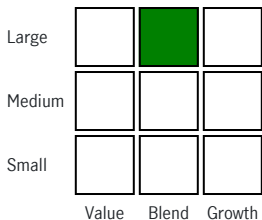

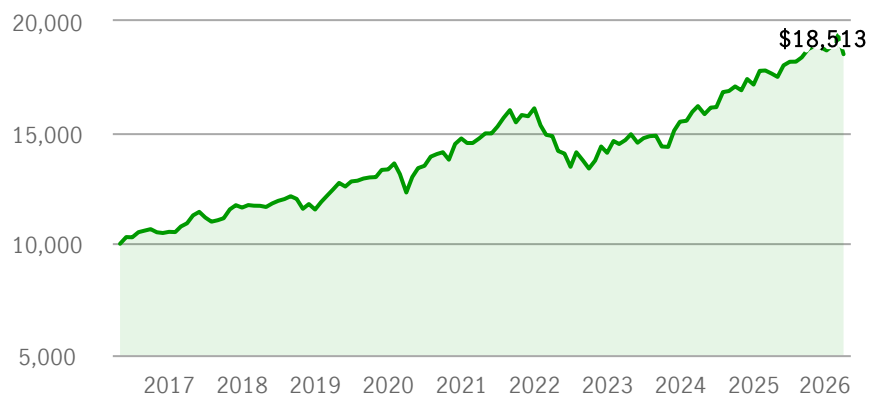

Within fixed income, the fund will take a core position in Canadian government debt.

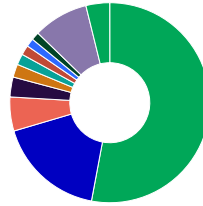

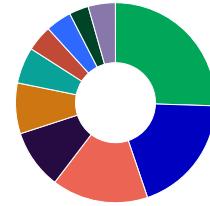

Geographic Allocation (%)



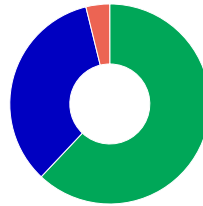

Sector Allocation (Equities) (%)



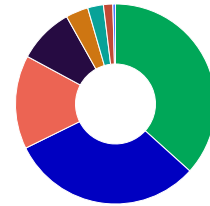
