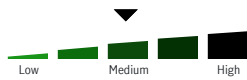

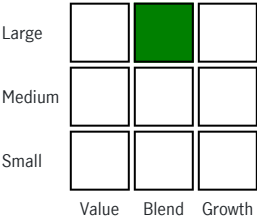

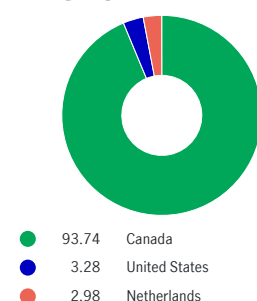

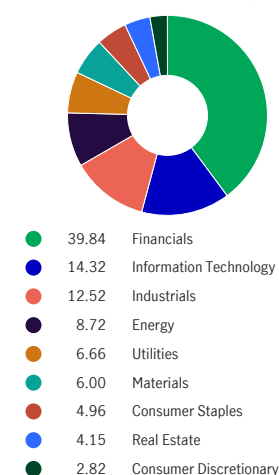

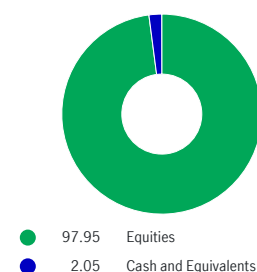
Geographic Allocation (%)
