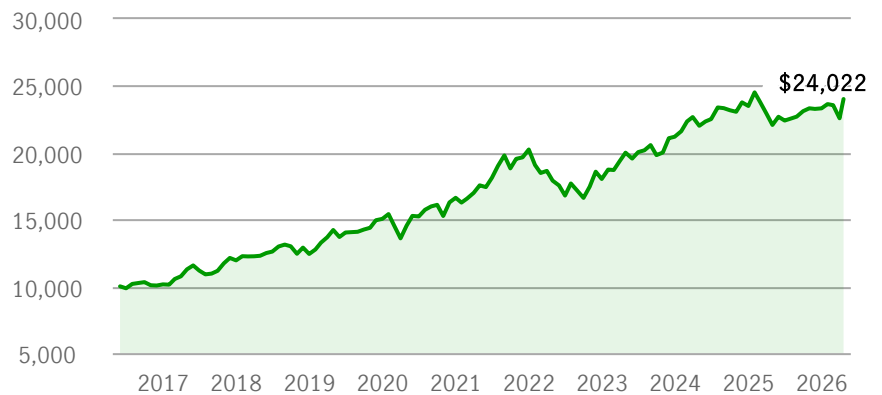

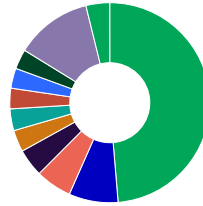

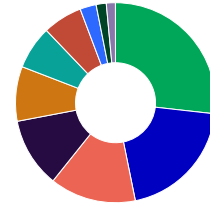

Geographic Allocation (%)



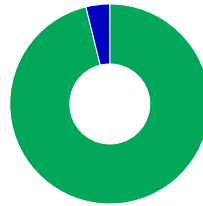
