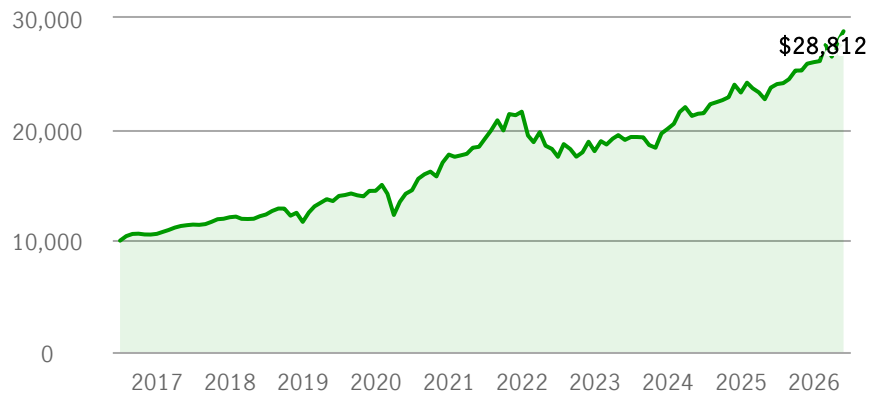

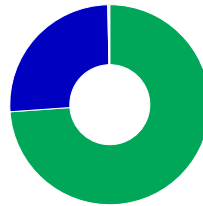

Geographic Allocation (%)



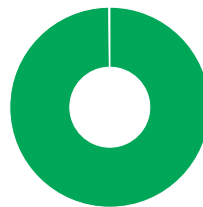
