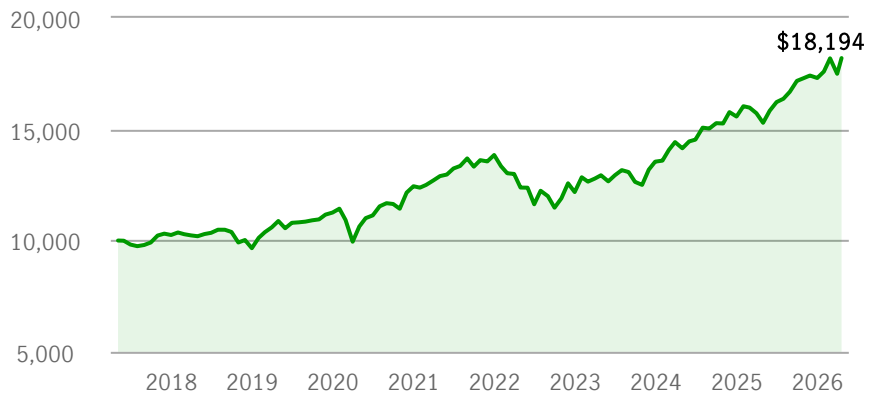

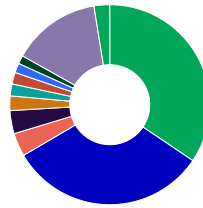

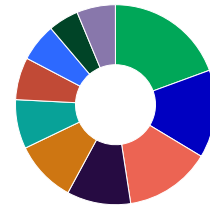

### Geographic Allocation (%)



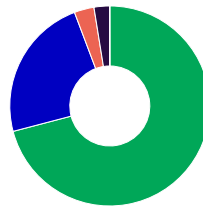

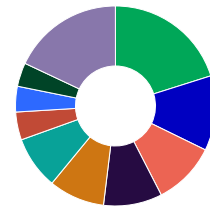
