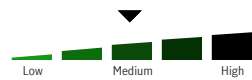

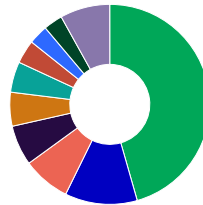

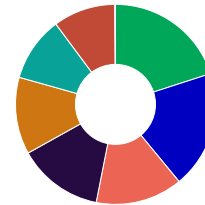

### Geographic Allocation (%)



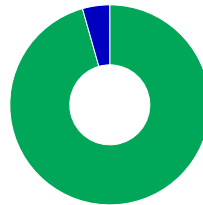
