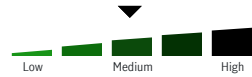

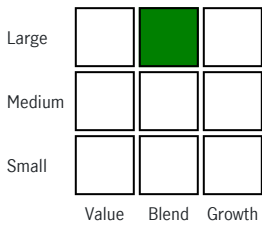

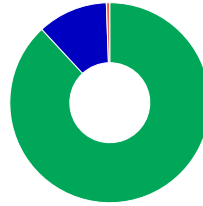

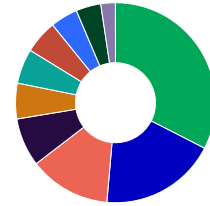

Geographic Allocation (%)



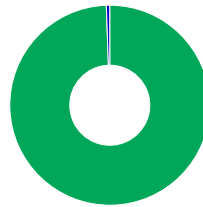
