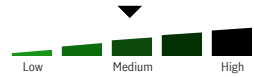

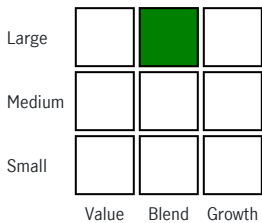

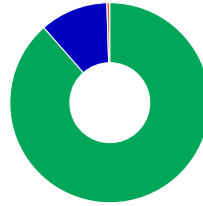

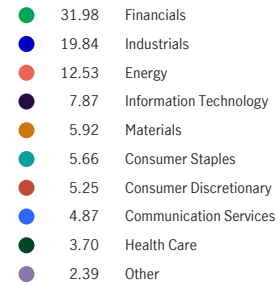
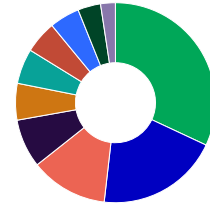

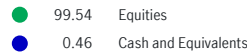
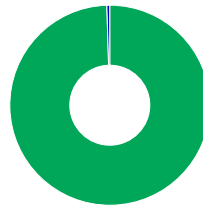
Geographic Allocation (%)
