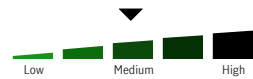

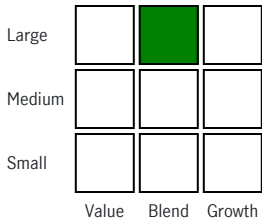

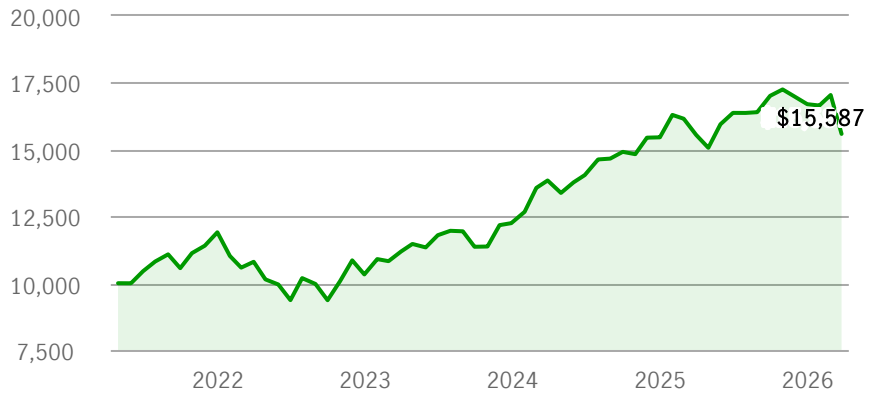

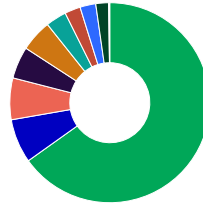

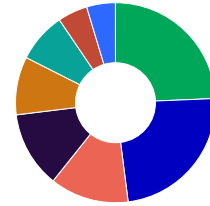

Geographic Allocation (%)



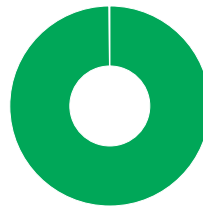
