- The investment grade corporate bond component of the Fund is managed based on a combination of
 top-down macroeconomic research and bottom-up fundamental credit analysis. The high yield
 component will be managed using fundamental credit analysis (bottom-up) to select those securities
 and sectors believed to be offering the best relative value. Stable, credit-worthy issuers will be
 emphasized in portfolio construction.
- Seeks to provide an enhanced yield profile in a time of low interest rates, and strives to insulate investors in times of rising interest rates.






