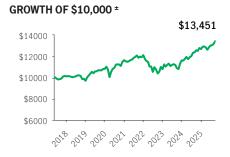

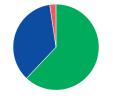

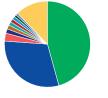
ASSET ALLOCATION %
