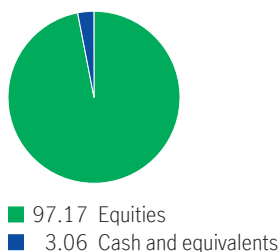

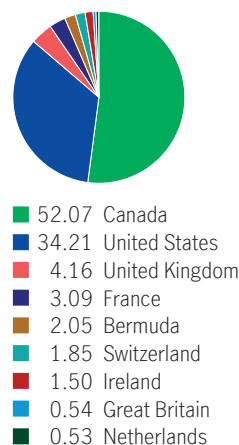

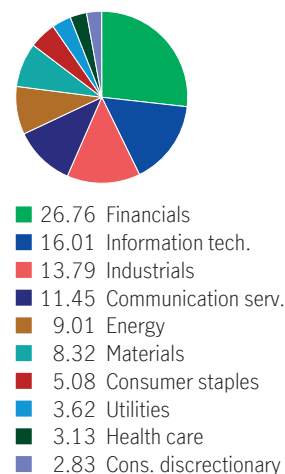
### ASSET ALLOCATION %
