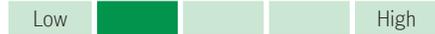






**ASSET ALLOCATION %**
