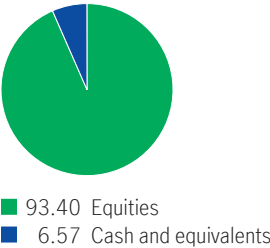

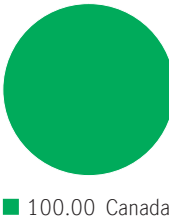
COMPOUND RETURNS ** %
