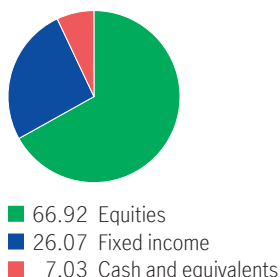

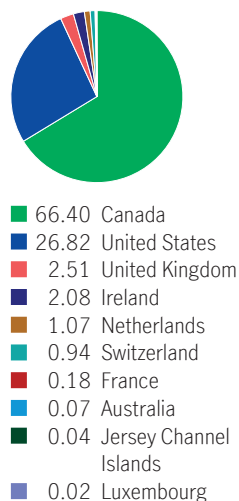
COMPOUND RETURNS ** %

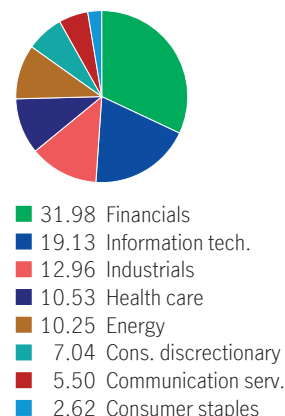
ASSET ALLOCATION %
