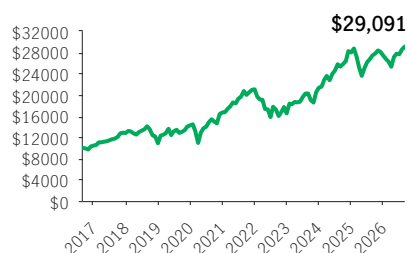

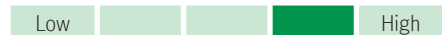

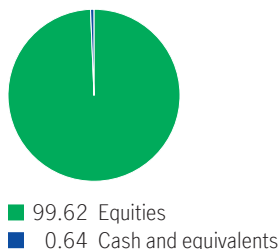

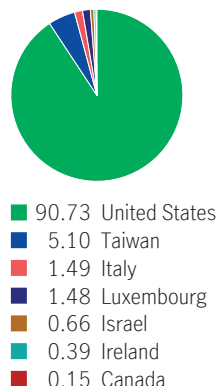

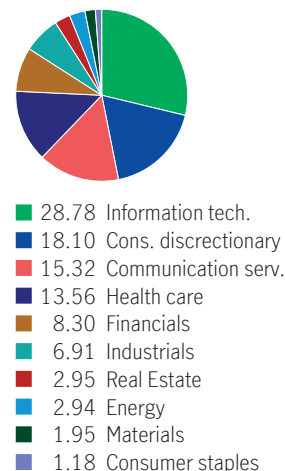
ASSET ALLOCATION %
