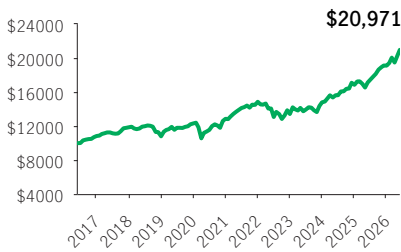

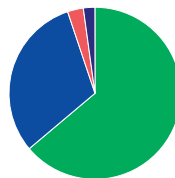

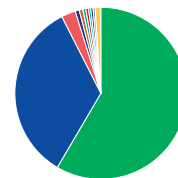

ASSET ALLOCATION %



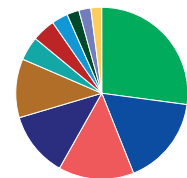
