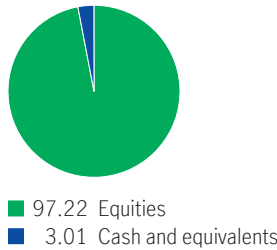

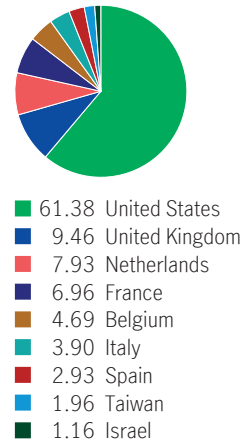

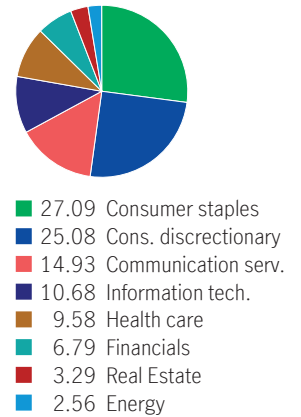
**ASSET ALLOCATION %**
