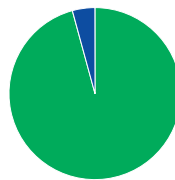

COMPOUND RETURNS %**

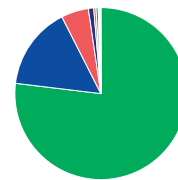
