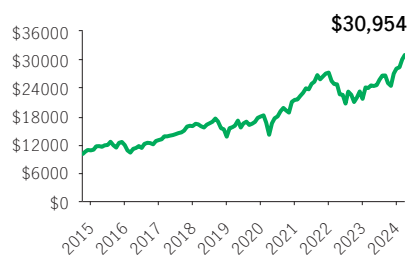

### GROWTH OF \$10,000 \*



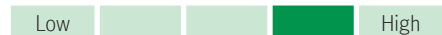

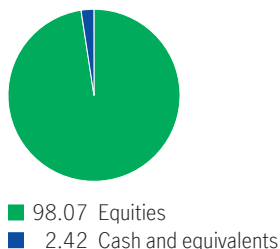

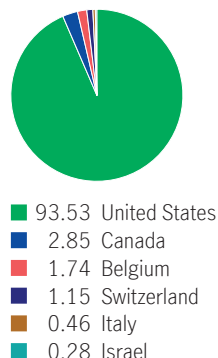

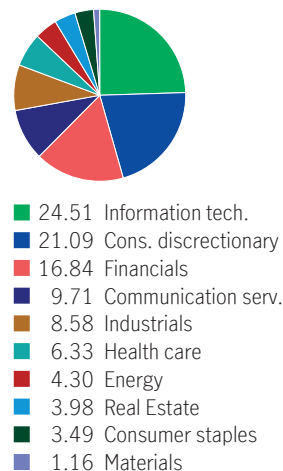
### ASSET ALLOCATION %
