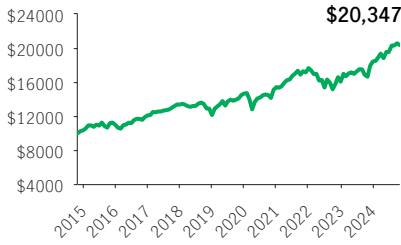

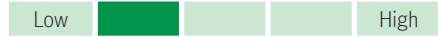

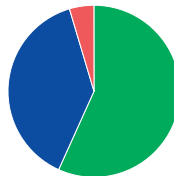

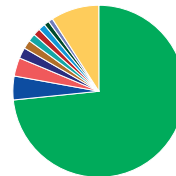

ASSET ALLOCATION %



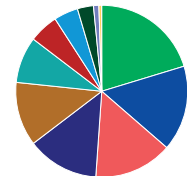
