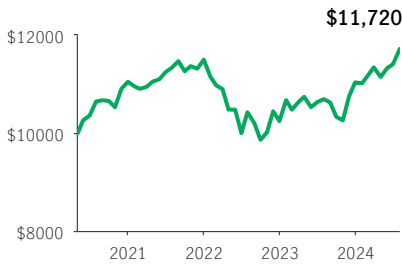

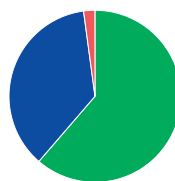

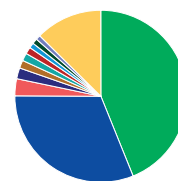


ASSET ALLOCATION %



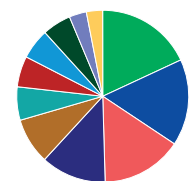
