



ASSET ALLOCATION %





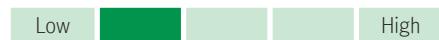
