Manulife smooths the yield of the PGIF to reduce volatility which over time, helps reduce the volatility of the policy values.

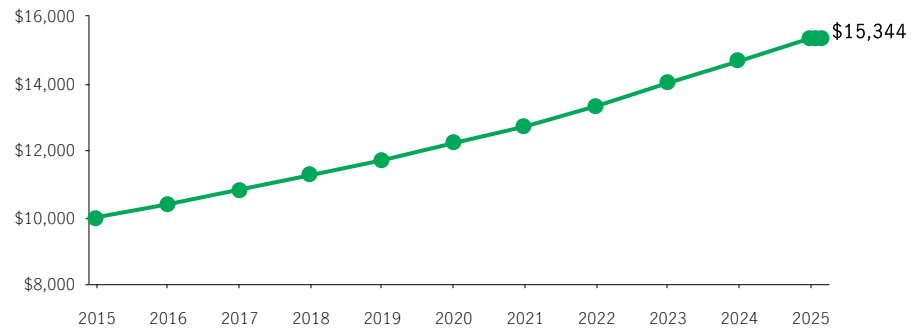

Growth of \$10,000 since inception for Performax Gold Investment Fund ±

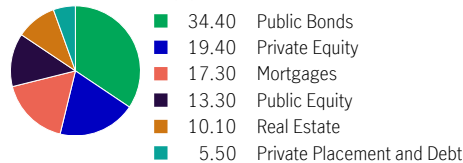

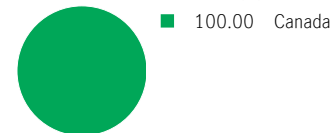
